## Who we are

**The Asylum Seeker Resource Centre (ASRC) is Australia’s largest human rights organisation providing support to people seeking asylum. We are an independent not-for-profit organisation whose programs support and empower people seeking asylum to maximise their own physical, mental and social well being. We champion the rights of people seeking asylum and mobilise a community of compassion to create lasting social and policy change. The ASRC movement is proudly supported by a community of committed volunteers and supporters.**

We began as a TAFE project in 2001, when Kon Karapanagiotidis, then a teacher, discovered that people seeking asylum were living in the community with virtually no basic support. This led to the creation of a student-run and community funded Foodbank which was launched from a tiny shop in Footscray with only a few boxes of food. That same year, the ASRC was established on 8 June 2001.

As an independent, community-led organisation, the ASRC is in a unique position to advocate for the human rights of people seeking asylum, free from the pressures of government or the private sector. For this reason, the ASRC has been able to take a leading position in the opposition of Australia’s asylum seeker policy, while offering alternatives to issues faced by people seeking asylum and refugees.

Today we are the largest independent human rights organisations for refugees and people seeking asylum. Our work on the front line with people seeking asylum informs our practice and enables us to effectively advocate for and alongside people with lived experience.

We offer more than 40 holistic programs that protect people seeking asylum from persecution and destitution, support well-being and dignity, and empower people to advance their own future.

We are proudly owned and run by our community and supported by a network of more than 1,000 volunteers and 100 staff in assisting around 7,000 people seeking asylum each year.

## Our vision

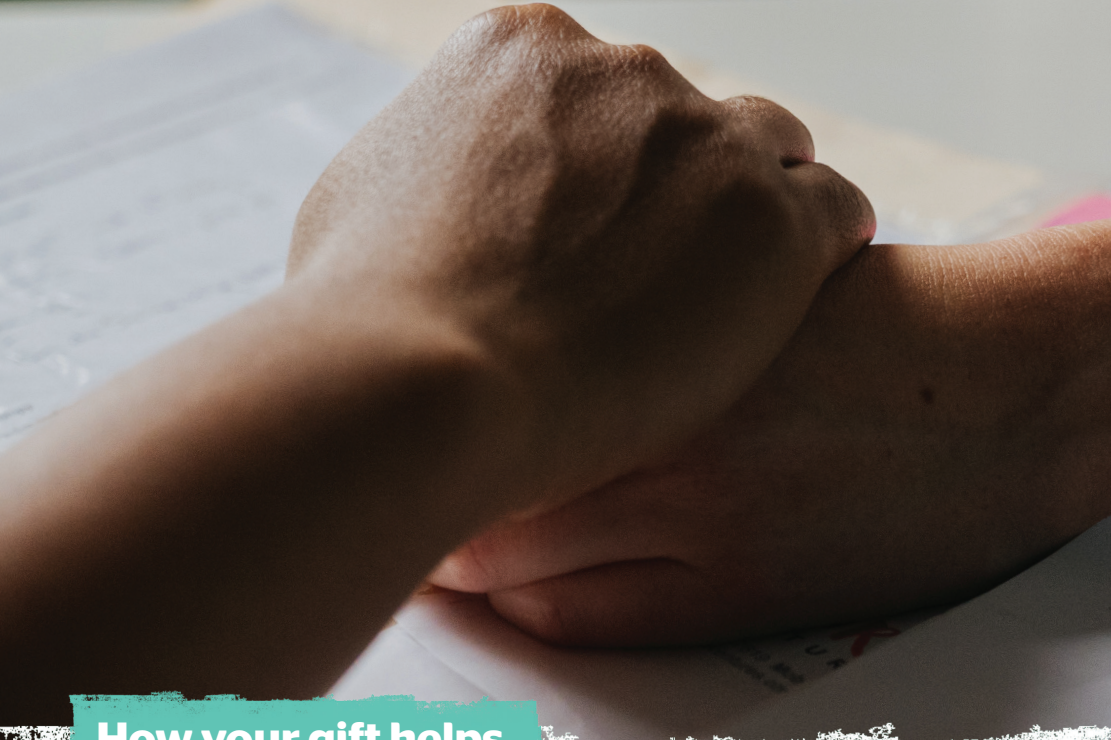
People seeking asylum and refugees can live safely, sustainably, independently and equally.

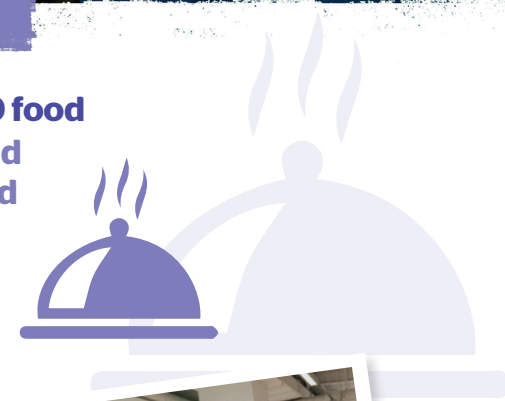

## Your gift can empower

Assist refugees and people seeking asylum to find **reliable work and develop career pathways** by partnering with employers to source suitable vacancies.



Help refugees and asylum seekers find **reliable work and career pathways** through a mentoring program.



**Our Dandenong Hub** brings together community sector organisations, each with their own areas of expertise, to provide a one-stop-shop for people seeking asylum to access services, programs and community activities that increase their well-being.





## Your gift can defend

**Actively engage in policy and law reform,** community legal education and training and outreach to detention centres.



**Advocate for people seeking asylum in onshore and offshore detention,** and provide emotional support, information about the complexities of Australia's policies, and make referrals to legal services.

**Offer holistic legal support at all stages of the refugee determination process** including expert immigration advice and representation.

Ali and Fatima\* are a married couple with a nine year old daughter, Kayla\*. Ali was working as a taxi driver but lost his job because of COVID-19. Ali suffers from chronic back pain due to a previous accident but like most people seeking asylum, Ali isn't eligible for any Government subsidies like Medicare or income support. With their case for asylum still pending before the Federal Circuit Court, and with no income or means of financial support, the family were at significant risk of homelessness and destitution. Fortunately, a friend of Ali's told the family about the ASRC and suggested they could get help with their situation.

When Ali and his family came to the ASRC they were at risk of homelessness, with no way to pay their rent, or bills, or put food on the table. Our caseworkers were able to provide rental support so they could keep their home, and ensured they had enough food to feed their family and medication to alleviate Ali's back pain.

Ali has since been supported back to work by our employment team who have been working closely with him to develop a plan that will provide a pathway to stable work. Ali's wife Fatima had never spoken with a mental health professional regarding the traumas of leaving her home. The family's caseworker organised for her to meet with someone from our Health Clinic and since then she has been regularly seeing a psychologist. Finally, their daughter Kayla has been able to access regular check-ups with Ellen in our Health Clinic, and the family now has a pre-paid prescription for medication to help manage her acute asthma.

**Your support provides hope and opportunities for people like Ali, Fatima and Kayla.**

# Frequently Asked Questions

## Can a gift in my Will make a difference?

Absolutely. A gift in your Will of any size plays a vital role in ensuring the ASRC can continue to protect, support and empower people seeking asylum so they can advance their own futures.

## What kind of gift can I give in my Will?

There are four types of gifts you can give in your Will:

### Residual

A residual gift is a portion of your estate, or the balance remaining after your loved ones and expenses are provided for. This is the best type of gift, and one we prefer supporters to consider because it maintains the relative value of your gift and automatically adjusts to changes in the value of your estate.



**Preferred Gift**

### Pecuniary

A pecuniary gift allows you to give a specific amount of money to the ASRC.

### Percentage

A percentage gift allows you to choose a proportion of either the residue of your estate, or your entire estate, to the ASRC.

### Assets

An asset is considered anything of value, such as property, shares, jewellery or works of art. We would accept the property or asset with the understanding that we would seek to sell it and liquidate the assets to fund our programs. This type of gift, while valued, incurs further costs and liabilities to the ASRC.



## **How do I leave a gift in my Will?**

There are three main steps to creating a Will.

1. Consider your loved ones and the causes to which you would like to leave a lasting legacy.
2. Choose the type of gift you would like to leave.
3. Meet with your solicitor and provide our name (Asylum Seeker Resource Centre Incorporated) and ABN (64 114 965 815).

## **I already have a Will, do I have to create a new one?**

If you already have a Will but would like to leave a bequest to the ASRC, you can do so by making a simple addition to your existing Will. Your lawyer can help you do this – this is called a ‘codicil’.

## **The ultimate goal of the ASRC is to one day close its doors, why should I leave a gift in my Will?**

While we hope the ASRC won't be needed forever, the needs of people seeking asylum don't just end once they are granted refugee status. We promise to remain agile and innovative in addressing the needs of refugees and people seeking asylum, allowing them not just to survive, but to thrive.

## **Can I choose what my gift is used for?**

We request that gifts are left to us free of prescriptions so that the ASRC has the freedom to dedicate the gift to where it is needed most. Such a decision is made by the ASRC Management team.

## **Who should I tell about my gift in my Will?**

Once you have remembered the ASRC in your Will we encourage you to let us know. You do not have to tell us, but we would love the opportunity to thank you and welcome you as Champion of Freedom.



# Suggested Wording

**Once you have chosen the type of gift you wish to give, take this slip with you and speak to your legal advisor to draft the appropriate clause. To ensure your intentions are followed, it is important to word your Will to reflect this. The suggested wordings for each type of gift are set out below:**

## **Residual**

I bequeath to the Asylum Seeker Resource Centre Incorporated (ABN 64114965815) the whole of the residue of my estate to be for purposes that it shall determine, and this bequest will be free from all duties. The receipt of this bequest by any authorised officer of the Asylum Seeker Resource Centre or successor organisation, shall form a valid discharge to my Executor.

## **Pecuniary or Percentage**

I bequeath to the Asylum Seeker Resource Centre Incorporated (ABN 64114965815) the sum of \$\_\_\_\_\_ / or percentage of my estate (complete as appropriate) to be used for purposes that it shall determine, and this bequest will be free from all duties. The receipt of this bequest by any authorised officer of the Asylum Seeker Resource Centre or successor organisation, shall form a valid discharge to my Executor.

## **Asset**

I bequeath to the Asylum Seeker Resource Centre Incorporated (ABN 64114965815) property or asset / freehold/leasehold property situated at and comprised in Certificate of Title No \_\_\_\_\_ (complete as appropriate). I direct my Trustee to sell said property and I bequeath the net proceeds of the sale to Asylum Seeker Resource Centre Incorporated to be used for its work as decided by their management team. The receipt of this bequest by any authorised officer of the Asylum Seeker Resource Centre or successor organisation, shall form a valid discharge to my Executor.
